
There are a lot of energy saving technologies on the market that could benefit the businesses and residents of Nashwauk.

WHAT IS A Conservation Improvement Program (CIP)?

CIP is a tool for commercial and residential utility customers within the City of Nashwauk service area to help save energy and provide money-saving resources. The City of Nashwauk is providing a no cost service to its customers to help provide energy efficiency assistance and financial incentives for conserving energy.



SERVICES FOR RESIDENTS

The City of Nashwauk provides rebates to residential customers who install energy-efficient technologies in their place of residence that save energy. SERVICES FOR BUSINESSES

The City of Nashwauk provides rebates to customers who install energy efficient technologies in new facilities or retro fit existing facilities. The City of Nashwauk encourages its customers to make energy efficiency upgrades through providing financial incentives to help buy down the cost of the project. Contact the utility company if you think your project may save energy and a custom rebate will be processed based on the amount of energy savings. The following is a brief list of items that qualify:

- Energy efficient lighting
- Lighting controls
- Variable speed drives
- Energy-efficient air conditioning
- ECM fans
- Air conditioning systems
- Refrigeration improvements
- Energy management systems
- Energy recovery units
- And more....

Maximum annual rebates are determined by a customer's average kWh billing. Contact Pam LaBine to determine if your project qualifies and the rebate amount for the project.
